ENTRY/ELIGIBILITY:

Open to members of the Housatonic Valley Art League. One or two entries may be submitted; one entry \$15, two for \$25, **Membership dues must be paid up.**

While we intend to hang all art work. No bin entries.

Each entry must be original. The following fine art will be accepted : oil, acrylic, watercolor, gouache, pastel, ink, pencil, scratchboard, monoprint, serigraph, relief print, collage, or mixed media (combination of the foregoing). No computer art or commercial reproductions. Works must be signed, dry and 'exhibit-ready'. **Frames must be have a proper hanging wire**, no saw-tooth hangers.

SIZE: NOT TO EXCEED **20 inches by 20 inches**

- FORMS :**
1. Attach completed uncut 3-part form, taped at top only to upper left back corner of frame.
 2. Sign liability WAIVER and SUBMIT at registration for art works to be accepted. .
 3. Artists may submit a one page (8.5/11) resume/cv for inclusion in a binder at the exhibition.
 4. \$15 or \$25 check for entry fee, made out to HVAL.

SALES :

All exhibition entries **MUST** be for sale and should be reasonably priced.
The maximum sales price for one piece cannot be more than \$1000. A commission of 30% for HVAL and the Dewey Hall will be deducted from all sales.
